

Ms Furlong, Pass onto Mr Moore.

The FACT is we all know that the UK population is to increase, that has been endorsed by the National Statistics office, but anyone could tell you and the NS office **that FACT**.

We also know-, as a FACT that Canterbury District has a **housing shortage**, even CCC officers and members accept that FACT

It is also a FACT that CCC officers and members have failed miserably to provide enough sites for housing, that has been the position for **many, many years**.

That position [shortage of housing] especially social housing [rentable accommodation] continuous.

A perfectly good site was offered to CCC-, SHLAA 135 for 245 homes to fill a social housing massive shortfall, currently that site has been excluded from the Local Plan, as indeed has the **owner, his agent from taking part in the objection to the Local Plan at Stage 2 sessions**.

That rejection by Mr Moore for SMPL agent to not be able to attend Session 2 recently endorsed by Inspector Moore, who oddly declares that CCC does not have a 5 Year housing plan, [we could help him with our objections at session 2] BUT Mr Moore will not hear our latest objection to the current live plan.

It is also a 'known' FACT that the Local Plan IF approved with the sites endorsed by CCC, and some embellished by Mr Moore after some sites were excluded **WILL FAIL** to provide enough homes.

The failure of the Local Plan is predictable.

Reasons are-, not only on previous population figures, but endorsed by up to date live ones from the NS office, particularly in the South East which includes Whitstable, every indication is WE NEED MORE HOMES.

Another FACT-, Two previous Government Inspectors have stated that Whitstable has a **shortage of homes**, Mr Moore appears to be blinded and deaf to those facts, [currently].

I acknowledge the Inspector can hold a further hearing on the latest NS office predictions, he clearly has the power to do that, **and exclude people if they do not fit his agenda**.

What will that session achieve? [if held].

I suspect tell Mr Moore what-, **Whitstable has- that is a housing shortage'**!

Surely he knows that by now.

TEN THOUSAND LOCAL RESIDENTS signed a petition on that subject and asked that SHLAA 135 was included to provide social housing in Whitstable, has the inspector not heard or got that yet? Does he really need another session to know that?

IF, and it is a big IF Mr Moore decides the necessity for another lengthy consultation with multi sessions, then we would like to be heard, but based upon HISTORY and Mr Moore previous exclusion of us we suspect that will also fall on deaf ears.

Mr Moore is blinded by CCC officers, who have labelled US non existent!

Mr Moore will recall when that was **recorded** at Session 1.

We will endure for no other reason to have our application logged [to be HEARED] if a session is necessary about what the NS office says about Whitstable housing shortage, but that has already been said by 2 previous Government Inspectors.
