I sent off the objection below in January 2023 - my views remain unchanged and I still strongly object for the same reasons.

I the undersigned wish to strongly object to the above development proposal under the Canterbury local plan 2045 and the proposed development of 1400 homes on Brooklands farm.

For the following reasons:

Southern water have stated that it will be at least 20-25 years until the long rock pumping station is able to cope with current demands on the existing usage this is now before the current large housing development on the land behind Grasmere Road - known as Grasmere Pastures is even completed.

How can you agree to a development that would put further on an already overloaded and antiquated system??

Currently there is a movement in parliament to ban the use of green belt and farm land for building which certainly applies to the above proposed development. The face of Whitstable is changing as more and more large overbearing housing developments are approved - like the one along the old Thanet Way - Whitstable Heights that interestingly is proving very slow to sell and NOT encouraging local residents to move on there with local talk about Hyde Housing encouraging Croydon residents to move down - so where is the perceived need?? Loss of hedgerows, historic trees and ancient farmlands that give Kent it's well deserved title of the garden of England is fast becoming diminished we need to act now to stop the loss of these wildlife havens alongside the animals and birds that will be come extinct and not recover from developments as large as these.
