#### LOCAL IMPACT

It is quite clear that it is only from National Government comes this pressure to build, build build. The needs of His Majesty's Government are entirely independent of the needs of the people of Canterbury and its district. This proposition to increase dramatically the number of houses with its suggestion that this will benefit our local communities is entirely misleading

#### IMPACT ON THE CITY

The very welcoming university city that we remember when we first moved to Fordwich forty years ago, has been systematically ransacked with overdevelopments. The fact that in recent years, there has not been a properly functioning Conservation Department has left our once loved city prey to ruthless developers.. The City Council's work over these years has meant that so many of our friends find a visit to Canterbury in the evening a very unpleasant and worrying environment. Therefore, an increase in the burden of development can only further destroy the positive ambiance of OUR city.

#### TRAFFIC

The enormous increase in our traffic over the past forty years presents a major health hazard in terms of the carbon monoxide that now threatens our health. The large roundabout at Northgagte has for so many years created a bottleneck of traffic and presents a grave threat to the people; who live in the vicinity. The fact that the City Council has allowed such large development in that area shows a terrible lack of care for all those people who live nearby. Simalarly, the Westgate Tower's bottleneck with its approaches to the proposed development at Blean expresses a scandalous lack of care for human life.
