To whom it may concern,

I object to Policy W4 Brooklands Farm.

Apart from the loss of exceptionally attractive countryside, I have serious concerns about the impact on the sewage system, and the lack of adequate infrastructure for traffic and health services in particular.

As we have seen in the past few years in particular, Swalecliffe sewage works is already unable to cope with existing demand resulting in serious illness for some visitors to local beaches. This is totally unacceptable for a town with a famous seafood tradition that aspires to be a tourist destination.

This development will significantly increase traffic on local roads, which have already come under increased pressure in recent months and made Whitstable a difficult place to get in and out of, especially in the summer months.

Local health services are already badly over-stretched with patients frequently unable to get beds in hospitals, pressure on pharmacies and our dentists are over subscribed.

It is also so sad to see another development proposed on open landscape, destroying local wildlife habitats at a time when we should be protecting them and being very bad for genuine biodiversity.
