I am writing to your department to let you know that I **strongly object** to the plan to build on the land known as Brooklands Farm.

In this locality we have already seen a large estate of the type you envisage for Brooklands. The large estate that has been build on the grounds of the Herne Bay Golf Course and surrounding rural area. Also at the time of writing another large estate 'Whitstable Heights' is being build at the other end of the Thanet Way. Plus there is a development going on in the area of Greenhill and even more development in Bullockstone.

This area cannot take any more re-development. The roads are already overfull of traffic, roads that the council seems to struggle to keep under repair as it is. The air pollution in this area due to the M2 is already high and we do not need it to rise higher by increasing the amount of traffic which more development, meaning more people, meaning more cars will definitely cause.
