Leo, you're a legend. Here goes:

One of the officers mentioned short-term benefits. I believe I covered that with the suggestion of lengthening the platforms in Sturry. I would like some serious investigation done on this, please, as I cannot for the life of me understand how this has not been looked at before. The wait time at the level crossing would be reduced significantly.

Mark Dance mentioned buses and how they have not been modelled. He also made the suggestion of using other companies to cover the rural areas. This has been done in Broad Oak and Hoath however the companies would not take bus passes and charged £5 per journey,

There was a reference to the Sturry Park & Ride; It's been noted that land has been designated in the Draft Local Plan for the Sturry P&R. Can we be assured that the facility will be reopening and when will this be - following completion of the Link Road or before?

In terms of bus lanes, (I think) Richard commented that they are 'critical to what they do'. With that being said, can KCC explain why only one bus lane will be installed on the Sturry Link Road, making it not fit for purpose or future proofed. Can we expect the same with the Eastern Bypass?

Mark Dance made reference to bus lanes on Sturry Road. Suggestion; as Sturry and Broad Oak Roads are a ring road in themselves, why not make them one way, with Sturry Road going into Canterbury and Broad Oak Road coming out of Canterbury, and put a bus lane on each.

Finally, in response to Peter's point about housing numbers; the sites that have been previously refused at Planning or rejected from the previous Local Plan, such as The Paddocks in Broad Oak or Popes Lane in Sturry for example, have been entered in this Draft Local Plan for consideration. How can that be, when they have been refused already. And in the case of The Paddocks, with the one of reasons for refusal being that the view to Bell Harry Tower would be blocked.
