## CONSULTATION FTC TOPIC PAPER No. 7

#### Introduction

- 1. This topic paper deals with the subject matter of consultation between Canterbury City Council and Fordwich Town Council (FTC) and Fordwich residents on the Canterbury and District Local Plan
- 2. There has been a lack and unreasonable delay to engagement with Fordwich Town Council and Fordwich residents. FTC arranged to meet CCC on 30/11/22 but CCC officers cancelled this meeting with less than 24 hours' notice (see timeline below). This meeting was then postponed for 6 weeks until 11/01/2023, a week before the end of the consultation period. On 15th/12/2022, CCC agreed to an extension for FTC but not for residents at this stage. CCC delayed offering Fordwich residents an extension until 09/01/2023, Many residents did not get this extension in time and so had responded with a lack of information.
- **3.** FTC requested information from CCC on 21/11/2022, treated by CCC as an unreasonable request, and FTC had to chase a response which was not forthcoming until 22/12/2022 (4 weeks later).
- 4. There was then a reluctance to extend the consultation for residents, this was not announced until 09/01/2023, a week before the deadline of 16/01/23.

Fordwich is directly affected by the new preferred route of the Eastern Movement Corridor which will dissect the parish of Fordwich and pass through the ancient woodland of the Parish of Fordwich.

26/10/2022 FTC Meeting Ward Councillor Louise Harvey-Quirke briefs meeting that she has fed back concerned comments from residents to CCC Cabinet. FTC plan briefing for briefing residents on 10/11/2022 and 12/11/2022

31/10/2022 Friends of Fordwich Meeting School Hall Fordwich opportunity for residents to discuss Draft Local Plan and express their concerns. Well attended c 30+

02/11/2022 CCC holds briefing for Parish Councillors Meeting lead by Peter Davis, Andrew Thompson and Leo Whitlock CCC representatives

FTC Councillors McCarthy and Green attended. Spoke to Andrew Thompson Why have Fordwich not been consulted?

CCC agreed to come to FTC to discuss the Draft Plan on 02/12/2022

FTC try to ensure it can still go ahead, ask ward councillors to help. Peter Davies adamant that it cannot go ahead FTC losing valuable consultation time.

30/11/2022 Peter Davies e mail confirms cancellation

12/12/2022 FTC e-mail Peter Davis requesting a date for rescheduled meeting first 2 weeks in January .. all FTC Councillors are available on 03/01/2023 but CCC officers cannot make a date until 11/01/2023 a week before the consultation closes and 6 weeks after the cancelled meeting. FTC ask for an extension

Annex E 14/12/2023 Ben Fitter-Harding Leader of CCC cancels meeting with FTC scheduled for 09/01/2023 reason 'As FTC will not have discussed the draft with officers prior to the meeting I do not feel it would be appropriate for me to attend' B F-H rescheduled for 02/02/2023

15/12/2022 FTC requested extension to 13/02/2023

15/12/2023 Peter Davies agrees to an extension for FTC to Monday 13<sup>th</sup> February but no extension for residents

20/12/2023 Greg Jones requests meeting with ward councillors. Louise Harvey-Quirke agrees to meet with Greg Jones on 29/12/23 No response from Georgina Glover

**Annex F 22/12/2022 CCC** respond to request for information see e-mail attached

09/01/2023 Louise Harvey-Quirke still unclear whether an extension to response applies to residents

Annex G 09/01/2023 15.48 Ben Fitter-Harding offers an extension for residents to MONDAY 13<sup>th</sup> FEBRUARY 2023

10/01/23 FTC organises workshops for residents to guide on completing responses.

11/01/2023 CCC officers (Peter Davies Director of Strategy and Ruth Goudie Director of Transport) Louise Harvey-Quirke, Georgina Glover meet with FTC Main points Stantec was not an original thought Ruth Goudie drew the 3 routes proposed to Stantec November 2021 The middle route rejected as goes through SSSI (Old Park) The Fordwich route does not appear to have been looked at in-depth no regard for Ancient Woodland or internationally renowned archaeological findings in the area.

17/01/2023 Special Meeting of the CCC Joint Transportation Board to discuss Local Plan Greg Jones KC (resident of Fordwich) speaks for 3 minutes as a member of the public to say that this is the worst Local Plan he has seen in his career in Planning.

### 02/02/2023 FTC meet online with Ben Fitter-Harding

FTC expressed how unhappy they were at the lack of communication by CCC and its officers given that Fordwich was severely affected by the proposals of the Draft Local Plan that dissects the parish of Fordwich. FTC lost at least 6 weeks of the consultation period and had to strongly request an extension and fight for an extension for residents.
