IMPORTANT


alone in the course of discharging a function of the authority (s31(7) *Localism Act 2011*)).

It is also a criminal offence to knowingly provide information that is false or misleading (or being reckless as to whether the information is true and not misleading)

If your authority adopts a new code of conduct you are required to notify the Monitoring Officer of any DPs before the end of 28 days beginning with the day on which the Code takes effect. Failure to comply with this requirement would not of itself be a criminal offence but could render you liable to action being taken against you under the Code.


